Office of the Attorney General, Saipan – Attorney General Edward Manibusan is pleased to announce the nomination and acceptance of Attorney General Chief Investigator Ikluk Masayos to attend the 292<sup>nd</sup> Session of the FBI National Academy ("FBINA") in Quantico, Virginia.

The FBINA is a professional 10-week course of study for U.S. and International Law Enforcement Leaders, which serves to improve the administration of justice in police departments and agencies at home and abroad, and to raise law enforcement standards, knowledge, and cooperation worldwide. Its mission is to support, promote, and enhance the personal and professional development of law enforcement leaders by preparing them for complex, dynamic and contemporary challenges through innovative techniques, facilitating excellence in education and research, and forging partnerships throughout the world.
